# **Board Orientation**

#### **Election of 3 members to the Hastinet Board**

M.Piercy was nominated and accepted the nomination.(Moved by S.Freeman , Seconded by L.Reid) carriedM.Piercy accepted the position of Hastinet board member

# Election of 1 Ontario Library Service (OLS) Trustee
